Requirements

Each applicant must

- Have a minimum of 1 year living in Lowell neighborhood, and/or significant involvement in the Lowell Community. The Lowell neighborhood is defined by the boundaries of Divisadero to Belmont and H Street to Blackstone.
- Have a minimum GPA of 2.0
- Submit the following:
 - your completed application and essay
 - one letter of recommendation
 - transcripts
 - proof of income (EBT card, pay stub, income tax statement)
- Demonstrate financial need as shown by an annual income of no more than twice the US 2017 Federal Poverty Level Matrix (see table below).

Size of the Award

A total of \$3,500 (target) will be given annually in the following ways

- 1 scholarship to a four year university in the amount of \$1,500
- 4 scholarships to a two year college or trade school in the amount of \$500 each
